# WELCOME.

Cllr Mrs S Smith welcomed everyone to the meeting.

# **DECLARATIONS OF INTEREST.**

None recorded.

# PILGRIMS.

Cllr Mrs S Smith wished to thank H.M. Bennett, Randall Parker Foods and now Pilgrims Foods for their continued support for the Village during the years they have been at the Tilley Down site.

Cllr S Smith introduced Emma Moss the HR Manager at Pilgrims Foods, Tilley Down.

Emma Moss spoke about the working relationship Pilgrims have with Appleshaw:

- Pilgrims try to work with the community and follow up any complaints received from the village.
- Speeding is an issue that it often raised. All staff are informed of this issue at their induction. Regular reminders are posted in the plant. All complaints received with a registration number of the vehicle are followed up and action is taken.
- Pilgrims have been kept abreast of the '20' mph proposals and are in full support of the scheme.
- All Pilgrims can do is try to manage the staff that work at the plant, unfortunately, they have no jurisdiction once an employee has left the site. Shift times have now changed and the end of the day is now 4pm. Reported incidents after that time are unlikely to be related to the site.
- Pilgrims also work closely with the Appleshaw School and are keen to promote
  Health and Safety. The Plant car park is open every day for parents to use when
  dropping off or picking up children The bottom gate opposite the school is open
  for access to the car park every day.

The issue of the Plant lighting was raised by a Member of the Public. Emma Moss stated that Pilgrims are aware of the issues with the plant lighting.

- Test Valley Borough Council Planners have been to look at the site lighting.
- The lighting is being looked at by a consultant.

- Some changes to the lighting have already taken effect. The direction of some of the lights have been altered and the times some of the lights are on have been changed.
- As there are staff/contractors on site at all times of the day and night the plant needs adequate lighting to adhere to Health and Safety guide lines.
- Emma Moss stated that she will keep the Parish Council informed of any further news and hoped that she would be able to come to the next Parish Council Meeting with an up-date.

Cllr Mrs S Smith thanked Emma Moss for comings and making Pilgrims position clear.

# MATTERS ARISING.

ALLOTMENTS The Clerk reported that the allotment bills and survey on having water supplied have now been sent out.

# **OUTSTANDING ITEMS - UP-DATE.**

- WALNUT TREES Cllr Mr T Burden reported that advice on planting new Walnut Trees has been received, it has been suggested that a 2m X 2m hole is dug and fresh soil added. Cllr Mrs T Burden will now speak to Mr A Burgess.
- NOTICE BOARD REFURBISHMENT On going.

Cllr Mrs S Smith reported that the Paruish Council have been approached by the PCC regarding the relacement of the Church Notice Board. They have requested that the Church Notice Board be placed on the Village Green side of the Church Wall to encourage people to read its contents, this could be shared with the Parish Council. There would be no cost to the Parish Council for the new Notice Board.

This was discussed at length and the feeling of those present was that it would spoil the look of the Green and that permission should not be given. The Parish Council noted this and will inform the PCC.
